Context

The 6th Europe Region Physiotherapy Congress will be held in Madrid, at the Palacio Municipal de IFEMA, on 5-6 November 2026. The event will bring together over 1,200 physiotherapists, researchers, educators, and institutional leaders from more than 40 European countries, serving as a key international forum for scientific and professional exchange in physiotherapy.

To strengthen the engagement and participation of national member organisations across the region, the Congress Organisers propose this institutional collaboration agreement. This agreement aims to facilitate the dissemination of Congress activities and promote high representation and attendance among the Collaborator's members.

General areas of collaboration

Active and Coordinated Dissemination: The Collaborator commits to disseminating the main activities, deadlines, and news of the Congress through its official communication channels, following the communication plan provided periodically by the Congress Organisers.

Direct Benefit to Members: Those members of the Collaborator will be eligible for a 15% or 20% discount on the official registration fees, contingent on the purchase of a registration package as detailed in section 3.

Institutional Recognition: The Collaborator will be publicly recognised as an "Official Collaborator" on the Congress website, social media, in the official Congress app, and on signage displayed during the event.

Detailed description of collaboration

The collaboration of the Partner will be implemented through the following actions:

Dissemination and Promotion

The Collaborator agrees to promote the Congress to its members using its own communication channels. To this end, the Collaborator will commit to a minimum of 10 communication actions throughout 2026, distributed as follows:

Official Newsletter / Mailings	4 dedicated mentions or articles	Email newsletter to members
Social Media Posts	6 posts	Tag the Europe Region of World Physiotherapy official accounts on your organisation's primary channels.
Website Banner / News Item	Permanent from acceptance until the Congress	Homepage or news section of the Collaborator's website

The Congress Organisers will provide a communication kit, including official texts, logos, and graphic elements in advance.

Registration Package Commitment

As an Official Collaborator, the organisation commits to promoting attendance through the purchase of a registration package for its members. The following options are available:

Package Level	Number of Registrations	Discount on Registration Fee
Collaborator Package 1	10 registrations	15% discount on the official fee
Collaborator Package 2	20 registrations	20% discount on the official fee

Conditions: These discounted registrations are exclusively for members of the Collaborator. The discount applies to all registration categories (early bird and regular). The Collaborator will be responsible for collecting the registration details from its members and coordinating with the Congress Organisers for the group registration process.

Benefits for the collaborator

Benefit	Description
Visibility	Inclusion of the Collaborator's official logo on the Congress website, in the official program, and on event signage.
Institutional	Recognition as "Official Collaborator" on the Congress website, app, and on-screen acknowledgements during plenary sessions.
Economic	Access to discounted registration packages (15% or 20%) for its members.
Strategic	Strengthening of the Collaborator's presence within European physiotherapy networks and increased visibility among international institutions and peers.

Duration and validity

- This collaboration agreement will be in effect from the date of acceptance until the conclusion of the Congress and the publication of its final report.
- The Congress Organisers will coordinate all communications and serve as the point of contact for the Collaborator.
- Either party may terminate this agreement by providing written notice at least 30 days in advance.
